Deployment Health Policy

- **Policy:**
 - DoD Instruction 6490.03. Deployment Health, 19 JUN 2019
 - DHA-PI 6490.03. Deployment Health Procedures, 17 DEC 2019
 - OPNAV Instruction 6100.3A. Deployment Health Assessment Process, 10 NOV 2014
- **Purpose:**
 - To identify health concerns and facilitate evaluation, care, and education throughout the deployment cycle.
- **Requirements:**
 1. Deployment health assessments are required for all deployments ashore greater than 30 days outside the United States, and
 2. For deployments and military operations based on health risk and the decision of the combatant commander, Service component commander or commander exercising operational control.

Deployment Health Compliance Information

- **Pre-DHA (DD2795)**
 - Due 120 days or less from theater entry date.
 - Form alone does not trigger “Deployment Event” in MRRS or requirement for DD2796 after deployment.
- **PDHA (DD2796)**
 - Due between 30 days before and 30 days after theater departure date.
 - Overdue at 31 days after theater departure date.
 - Expires: at 89 days after theater departure, as DD2900 (PDHRA) is due beginning 90 days after theater departure date.
 - PDHA (D2796) is no longer required once the PDHRA (DD2900) is DUE. Complete and certify the DD2900 (PDHRA) instead.
- **PDHRA (DD2900)**
 - Due between 90 and 180 days after theater departure date.
 - Overdue 181 days after theater departure date.
 - Expires: Does not expire.
 - Exception: Another deployment cycle begins and D2795 (Pre-DHA) is completed, unless the service member did not deploy as planned.

DHA Exemptions

- Shipboard operations that are not anticipated to involve operations ashore or health risks that are beyond the scope of standard shipboard occupational health programs.
- Deployments of shorter duration, 30 days or less, outside the United States.
- Deployments within the United States and its Territories.
- Deployments to enduring locations within operational areas, i.e., Japan, South Korea, Germany, Spain, Italy, and Bahrain (Manama).
 - Enduring Location Master List (ELML) is classified, periodically modified per Deputy Assistant Secretary of Defense (Plans & Posture), and accessible to the Medical Intelligence Officer/POMI or similar designee via SIPR.

Note: Shipboard deployments on foreign vessels are NOT exempt from the deployment-related health assessments.

Commander Directed DHAs

- **NORTHCOM – DHAs are required for deployments to Southern Border Operations.**
- **CSGs, Navy Surface Forces Commanders – Identified Service members deploying to, redeploying from (returning from deployment), or have redeployed (returned) from the Weapons Engagement Zone (WEZ) in the CENTCOM AOR are required to complete the DHAs.**
- **CENTCOM – DHAs are required for deployments to AOR except Bahrain and shipboard.**
 - **NAVCENT – DHAs are required for deployments greater than 30 days on ground to Isa AB Bahrain.**
- **SOUTHCOM – DHAs are required for deployments greater than 30 days on ground to GTMO Cuba.**

Commander Directed DHA Process

- **Combatant commander, Service component commander or commander exercising operational control issues a directive/mandate to unit(s) to complete the DHAs due to health threats/concerns during the deployment, regardless of deployment location or duration.**
- **Unit identifies Service members involved/associated with the deployment/incident and directs completion of the DHAs in EHA based on DHA compliance timeframes.**
- **Unit representative with MRRS access (usually medical) creates the DHA requirement in MRRS Deploy tab and monitors compliance.**
- **USFF BUMED DHA FM can assist in mass upload of DHA requirements in MRRS and can track/provide compliance update per EHA and MRRS upon request.**
 - **To assist, Unit POC provides a roster of Service members involved in the deployment to USFFC (EA for DHA per OPNAVINST 6100.3A). The roster must include the following information: Name, Rank, DoD ID, Theater Entry Date, Theater Departure Date, Destination COCOM, and Deployment Location/Country.**

Commander Directed DHAs

For the Marine Corps

- Due to the nature and ability of UDPs and MEUs to be redirected to “hotspots,” Marines on UDP or MEU require the Pre-DHA DD2795 regardless of where they are permanently stationed or coming from.
- Marines on exercises which are outside the U.S. for greater than 30 days require DRHAs.
- Embassy Security Guard Marines are required to complete DRHAs unless the country location is on the Enduring Locations Master List.
- Marines deploying to Bahrain, regardless of location within the country, are required to complete the DRHAs.

Deployment Health Compliance

DoDI 6490.03, Deployment Health, 19 JUN 2019; DHA-PI 6490.03, Deployment Health Procedures, 17 DEC 2019; OPNAVINST 6100.3A, DHA Process, 10 NOV 2014

Purpose: *To identify health concerns and facilitate evaluation, care and education throughout the deployment.*

Requirements: *Deployments ashore greater than 30 days outside of the United States or Commander directed.*

Exemptions: *Routine shipboard deployments; Deployments of 30 days or less; Deployments within US and its territories; Deployments to enduring locations, i.e., Japan, South Korea, Spain, Italy, Germany, & UK.*

Deployment-Related Health Assessments Requirements Timeframe

- (contains DMHA required questions)
- Required within 120 days prior to deployment
- Online form and provider certification

DD2978
IT MHA

- Required for every 180 days deployed while in theater.
- Online form and provider certification

PDHA

- Required between 30 days prior and 30 days after deployment return
- Online form and provider certification

DD2900
PDHRA

- (contains DMHA required questions)
- Required between 90-180 days after deployment return **BUT DOES NOT EXPIRE**
- Online form and provider certification

DMHA
1 YR/PHA

- PHA periodic health assessment or standalone DMHA
- Required within 181-545 days after deployment return (181 days-18 months)
- Online form and provider certification

- Required within 546-910 days after redeployment (18 months-30 months) **BUT DOES NOT EXPIRE**

Commander USFF (Supported Commander)	<ul style="list-style-type: none">• As Executive Agent (EA) monitor compliance and ensure policy enforcement.• Produce Quarterly PDHA/PDHRA Compliance reports to CNO via OPNAV N17.• Conduct monthly DHA Program Training.
BUMED	<ul style="list-style-type: none">• Provide medical support services to complete DHA.• Ensure individual IMR is accurate and current to facilitate smooth deployment process.• Provide OPNAV (N17) medical policy guidance related to DHA process.• Provide health record review for DHA deficiencies upon check-in and check-out. 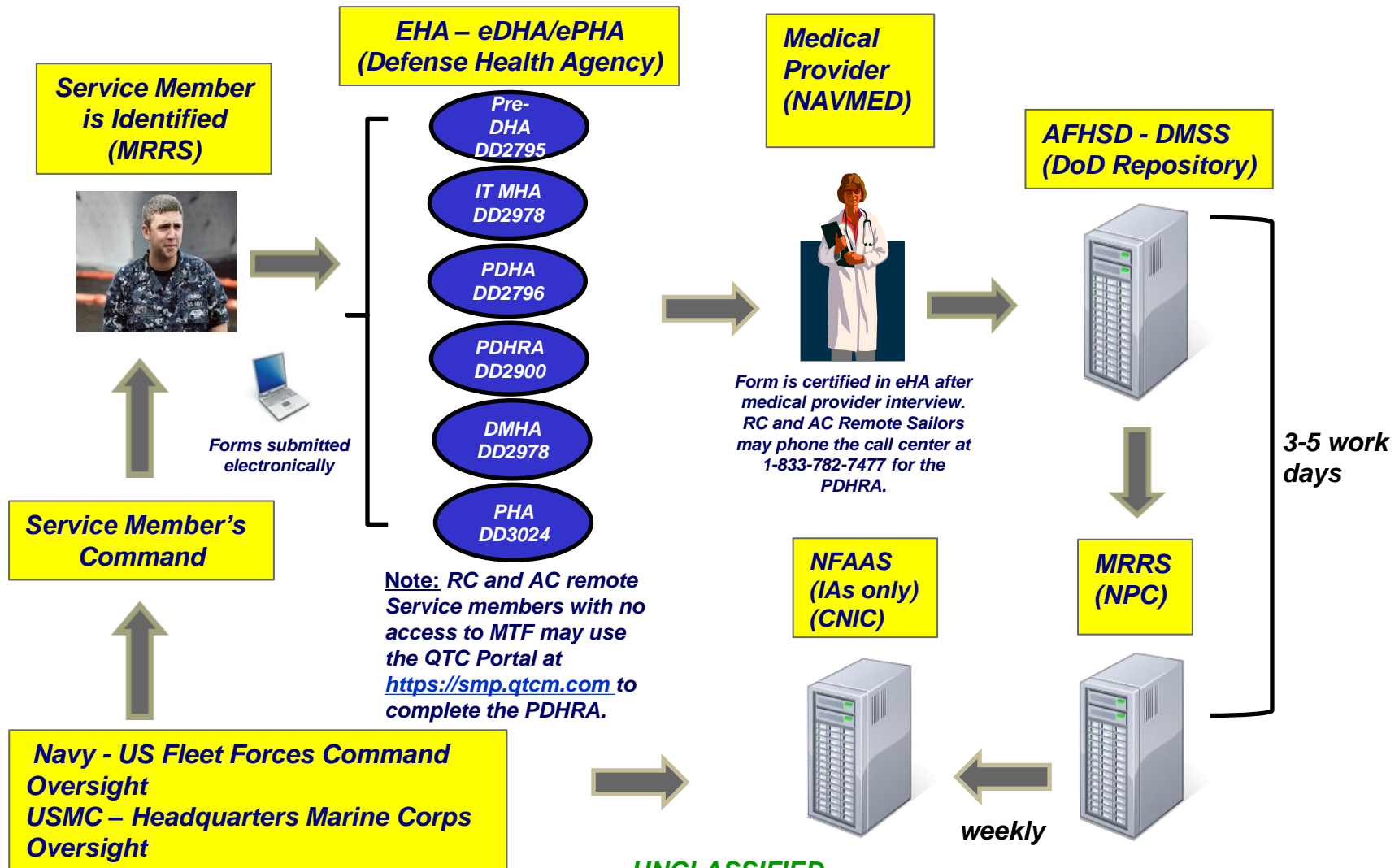

Navy and Marine Corps Force Health Protection Command (NMCFHPC)	<ul style="list-style-type: none">• Maintain the EHA - Electronic Deployment Health Assessment (EHA - eDHA) database and analysis of DHA information.
Commanding Officers	<ul style="list-style-type: none">• Ensure targeted Service members<ul style="list-style-type: none">– are briefed on deployment health threats.– complete required DHAs.– receive the appropriate follow up PDHA and PDHRA in coordination with medical providers.– DHA status is validated as part of check-in and check-out process.

Complete a Deployment Health Assessment

Completing a DHA (Pre-DHA/DD2795, PDHA/DD2796, or PDHRA/DD2900) is a two-part process:

- 1) Fill out and submit the DHA form online via the EHA Web application at <https://eha.health.mil/eha/>. **For PDHRA only:** Reserve component and Active component Service members remotely-located (TriCare Prime Remote enrolled and without access to a military treatment facility (MTF)) can utilize the DoD RHRP contract support services, QTC, to complete the PDHRA/DD2900. The Service member must register on the QTC portal first using the following link <https://smp.qtc.m.com>.
- 2) Once the DHA is submitted on-line, please schedule a person-to-person assessment with a medical provider at the nearest MTF to have your DHA medically certified. **For PDHRA only:** Reserve component and Active component Service members remotely-located (TriCare Prime Remote enrolled and without access to an MTF) can utilize the DoD RHRP Call Center at 1-833-782-7477 for medical certification.

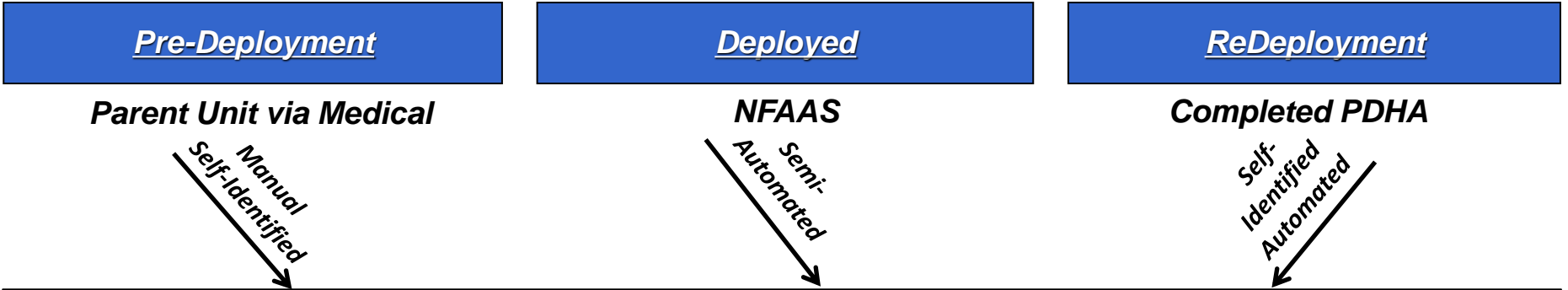
For Sailors supported by other Services' medical facility, the DHA can be completed in MEDPROS (Army) or ASIMS (Air Force).

Program Challenges

- **No automated pay and personnel integrated system for deployment health assessment accounting.**
- **MRRS user error - incomplete deployment data; deployment events with unmet DHA criteria; duplicate deployment events; manual entries of DHA completion dates.**
- **Lack of maintenance of deployment information in MRRS – orders cancelled or modified; Not exempting for PDHA/PDHRA when SM remained in enduring location; SM deployed again.**
- **Lack of knowledge of staff that provide DHA support.**
- **Gun decking of DHA completion.**
- **MRRS and NFAAS PDHA/PDHRA due and overdue notification being ignored by SM.**
- **Service member completing the wrong form and medical provider certifying the wrong form or all uncertified forms.**

Good afternoon BSO & TYCOM POCs.

BLUF: TYCOMs be aware of the command/commander directed DHA requirements for your redeployers. Completing the assessments within the defined timeframes is important and applies to the compliance rate. Just completing them outside of the defined windows (PDHA: +/-30 days of redeployment, PDHA: between 90 and 180 of redeployment).

Two important items in this correspondence: DHA February Biweekly Update (20 Feb 2025), and PDHRA Long Overdue Lists (20 Feb 2025).

1) DHA Biweekly Update - February 2025

NOTE: The data included in this update is reflected on MRRS data of 20 February 2025. PDHA & PDHRA compliance rates are reflected accordingly on the attached slides. Navy-wide PDHA compliance rates for January 2025 Redeployers is 66% and February 2025 is 56%. Navy-wide PDHRA compliance rates for August 2024 Redeployers is 26% and September 2024 Redeployers is 1%. All compliance rates are **Unsatisfactory**. Refer to your respective BSO & TYCOM for compliance rates. This update provides you with a snapshot of where your respective BSO's status. As you would imagine, "Unsatisfactory" compliance rates are unacceptable. Providing you with this information arms you with more than enough information for your subordinate UICs to improve their compliance rates per established policy.

The attached DHA Biweekly Update provides you with ample information for your subordinate units to effect changes to improve compliance rates where needed. Direct your attention and action for each assessment in the slide deck which provides not only the numbers of statuses, but also and most importantly, an Excel spreadsheet of the individuals that have a DHA requirement to be completed, whether it is Due, Overdue or Long Overdue.

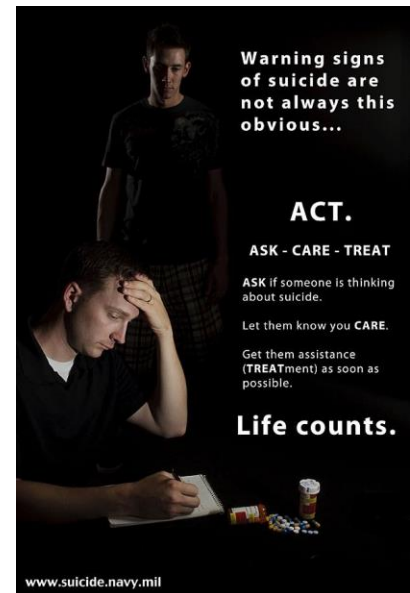
Impact if DHA Requirements were not Met

- Negative effect on PHA, IMR, PRT completion
- Command readiness & effectiveness degraded

- **Long Term**

- Consequences of unaddressed health needs

- Failure to meet Congressionally mandated program
