- 2. The underlying investigation was reviewed in accordance with reference (a). Further endorsement is unnecessary, therefore the investigation is final. The subject line was modified to ensure proper identification of the investigation for administrative purposes.
- 3. The findings of fact, opinions, and recommendations of the investigating officer are approved.
- 4. I concur with the recommendation of the Commanding Officer, USS GEORGE WASHINGTON (CVN 73), and find IC3 Huffman's death, occurred in the line of duty and not due to the member's own misconduct.
- 5. Per section 0229(d) of reference (a), a copy of the investigation will be forwarded to Commander, Navy Personnel Command (PERS-62).
- 6. In accordance with section 0228(b) of reference (a), upon receipt of final autopsy and medical documents, Commanding Officer, USS GEORGE WASHINGTON (CVN 73), shall forward documents by separate correspondence via the review chain, with appropriate reference to the report of investigation and forwarding endorsement.

1. Enclosure (1) documents IC3 Huffman's death resulting from apparent suicidal hanging, and is forwarded for the General Court-Martial Convening Authority's line of duty determination required by paragraph 0229(d) of reference (a).

- 2. The Line of Duty Investigation commenced on 11 April 2022; however, the investigation by local law enforcement remains ongoing and is expected to take several months before concluding. IC3 Huffman's death is currently documented as resulting from suicidal hanging. There is no indication that the incident is a result of any misconduct on the part of the Sailor. It is unnecessary to await the medical examiners official report of the manner and cause of death. Based on the facts and circumstances surrounding the member's death, the medical examiner's findings would not impact this line of duty determination.
- 3. Based on enclosure (1), I recommend finding that IC3 Huffman's death occurred in the line of duty and not due to the member's own misconduct as defined in paragraphs 0217 and 0229 of reference (a).

Preliminary Statement

- 1. Pursuant to enclosure (1), and in accordance with reference (a), I conducted an investigation into the circumstances surrounding the death of IC3 Natasha Huffman that occurred off base in Hampton, Virginia, on 10 April 2022. Due to the ongoing investigation by local authorities, supported by NCIS, I was not able to collect any evidence or interview potential witnesses to the incident. I consulted with USS GEORGE WASHINGTON's Deputy Command Judge Advocate, LT (b) (6), (b) (7)(C) JAGC, USN, for legal direction. This report was not completed within the initial deadline; an extension of time was granted in order to receive the Death Certificate.
- 2. The Office of the Chief Medical Examiner has yet to release the manner and cause of death due to the pending investigation. However, I was able to obtain the service member's Death Certificate and attach as part of the record, which identifies the cause of death.

Findings of Fact

- 1. On 10 Apr 22, the command received notification from EM1 (b) (6), (b) (7)(C) a Sailor assigned to the USS GEORGE WASHINGTON, of an alleged suicide involving IC3 Natasha Huffman [Encl 2].
- 2. EM1 was present at IC3 Huffman's residence at the time of the alleged suicide [Encl 2].
- 3. The evening of 09 Apr 22, EM1 slept on the couch while IC3 Huffman slept in her bedroom [Encl 2].
- 4. EM1 awoke around 1145L to find IC3 Huffman suspended by a ligature in her closet, deceased, at which point he contacted 911 [Encl 2].
- 5. EM1 contacted ICC to report the incident to his chain of command [Encl 2].

- 6. An autopsy was performed on IC3 Huffman on 11 April 2022; however, the results are not yet releasable, and will not be for an extended period of time.
- 7. To date, no investigative materials have been received by the command nor has the manner and cause of death been officially released by the Medical Examiner.
- 8. IC3 Huffman's Death Certificate was provided on 05 MAY 22, and indicates the cause of death as suicidal hanging with belt ligature. [Encl 3].

Opinions

- 1. IC3 Huffman's death was a result of a suicidal hanging. Per reference (a), even if there was evidence of a bona fide suicide attempt, "in view of the strong human instinct for self-preservation, suicide and a bona fide suicide attempt creates a strong inference of lack of mental responsibility."
- 2. IC3 Huffman's death was in the line of duty. The outcome of the local investigation will have no impact on this line of duty determination. There is no indication of any misconduct on the part of the member. IC3 Huffman's death is an apparent suicide, and not the result of her own misconduct.

Recommendations

1. I recommend the command submit this report or a similar report to the General Court-Martial Convening Authority (Commander Naval Air Force Atlantic), detailing the circumstances of IC3 Huffman's death, with the finding that her death occurred in the line of duty and was not due to her own misconduct.

- 1. Per Chapter II of reference (a), you are appointed to conduct an investigation into the facts and circumstances surrounding the death of IC3 Natasha Huffman, USN, in Hampton, Virginia on or about 10 April 2022. If you have not previously done so, read Chapter II of reference (a) in its entirety before beginning your investigation. Refer to appendix A-2-K of reference (a) for a list of matters that should be included in your investigation report, as applicable.
- 2. You are directed to make one of the three following determinations concerning the death of the subject service member: (1) the death occurred in the line of duty and not due to the member's own misconduct; (2) the death occurred not in the line of duty and not due to the member's own misconduct; or (3) the death occurred not in the line of duty and due to the member's own misconduct.
- 3. In accordance with references (b) and (c), you are hereby authorized to receive, review, and discuss protected health information with appropriate providers concerning IC3 Huffman. The specific protected health information covered is anything in IC3 Huffman's medical record or mental health records regarding the incident specified above. The disclosure of IC3 Huffman's protected health information is subject to the minimum necessary to execute the military mission of conducting this investigation.
- 4. Submit your written findings in the format provided in appendix A-2-e of reference (a) by 25 April 2022. You may seek legal advice from LT (b) (6), (b) (7)(C) JAGC, USN, Deputy Command Judge Advocate, USS GEORGE WASHINGTON (CVN 73), during the course of your investigation.



1. On 10 Apr 22 at 1145, I received a call from EMI (b) (6), (b) (7)(C), one of the Sailors in my division, informing me of IC3 Natasha Huffman hanging herself in a closet in her home.

2. I verified thay EM1 had called 911 prior to calling me; he said yes. I asked if IC3 Huffman was okay the night before and was told she wanted to sleep in the bedroom, so he slept on the couch.
